SH 130 Concession Company, LLC is working in collaboration with the Texas Department of Transportation to finance, develop, design, construct, operate and maintain segments 5 & 6 of SH 130. Segments 5 & 6 of State Highway 130 are a 40 mile stretch of highway that will connect IH 10 just east of Seguin with SH 130/SH 45 SE toll roads in south Austin. The project will take three years to construct and provide four new main lanes (two northbound and two southbound) between Lockhart and Seguin.
